

Instructions for participation in the event

Frankfurt Cancer Conference / 24-26 August 2021

Participation requirements:

Every participant must be registered for the event. Personal data are recorded.

Access to the University buildings is only permitted for people with a certificate according to § 3 CoSchuV:

- Certified negative rapid antigen test (daily and not older than 24 hours), to be conducted in a test center or pharmacy, or
- COVID-19 Vaccination Certificate according to § 2 No. 3 of the COVID-19-Schutzmaßnahmen-Ausnahmeverordnung (at least 14 days after the second vaccination dose), or
- Proof of recovery from COVID-19 according to § 2 No. 5 of the COVID-19-Schutzmaßnahmen-Ausnahmeverordnung (not older than 6 months).

The Certificate must be presented together with an official identification document (ID card, passport, etc.) upon entering the university building.

The following persons may **not** take part in in-person events at Goethe University:

- Individuals suffering from acute respiratory or feverish illnesses.
 In case of allergy-related symptoms, proof of this must be provided (allergy passport or current medical attestation).
- Individuals who have had contact with a person with a confirmed SARS-CoV-2 infection within the previous 14 days.
- Individuals subject to an official quarantine order or in whose household a member is subject to an official quarantine order.
- Individuals who have stayed in an international high risk area or viral variant area designated by the Robert Koch Institute within the last 10 days.

I assure to comply with the following rules of conduct on site:

- There is a general obligation to wear medical masks (surgical masks or protective masks of the standards FFP2, KN95, N95 or comparable, without exhalation valve) in the buildings of the Goethe University and at all in-person events until a seat is taken. At outdoor events, the obligation to wear masks may be omitted if the minimum distance of 1.5 meters can be maintained. The detailed list of areas in which masks are compulsory can be found on the Corona website of Goethe University: Goethe University - Coronavirus - Information for Employees
- **Keeping distance** (at least 1.5 meters).
- Coughing and sneezing etiquette (cough and sneeze into the crook of your arm).
- Avoid shaking hands and closer physical contact
- Hand hygiene (washing with soap for at least 20 seconds).
- There is a risk of contact infection! Therefore, please note the following behavior:
 - Wash hands before and after using the premises / workplaces and work equipment
 - o Do not touch the face (mouth / nose) during the entire stay
- No objects may be exchanged between people and then passed on



I give my assurance that I will report to the host of the conference immediately if within 5 days after the conference:

- I, or a member of my household, receive a positive result from a corona test.
- I develop symptoms of a SARS-CoV-2 infection AND I am ordered by a physician to take a corona test.

I have been informed about the increased risk and the necessity of special measures when participating on-site if I belong to one of the risk groups defined by the Robert Koch Institute for a severe course of COVID-19.

With my signature I confirm the voluntary nature of participating on-site as well as that I am aware of the increased risk of on-site participation.
